Subject: Implementation of Air cargo Community System (ACS) for courier at GMR Hyderabad Air Cargo Terminal.

Dear Trade Partners,

Attention is invited to all courier agents/operators operating at GMR Hyderabad Air Cargo Terminal, Rajiv Gandhi International Airport, Hyderabad. As part of our e-freight initiative aligning with the Indian Government's "Digital India" vision, we are implementing the next generation Air cargo Community System (ACS) at our Air Cargo Terminal and this service will be run and managed by our technology partner M/s Kale Logistics Solutions Private Limited (KLSPL).

ACS is an electronic platform for digital interactions between various airport stakeholders such as airlines, shippers, freight forwarders, customs brokers, custodians, ground handlers, transporters, consignees, Chambers of Commerce, bonded truckers etc. This platform would lay the digital foundation for eliminating paperwork at our Air Cargo Terminal as well as faster processing of cargo as it reduces duplicate entries for all information and would help the community attract more cargo through improved digitized services. It would also help in enhancing security and planning processes which can further reduce dwell times at the airport. It would help the eco-system to comply with global regulatory and industry requirements such as e–AWB, e-CSD and other e-Freight initiatives and bring in transparency and visibility. It is also worth noting that the Kale ACS portal and services are already in use at other major airports in the country including Mumbai and Bangalore.

This circular is being issued to inform all concerned entities that the ACS portal services by Kale Logistics will be shortly available at www.gmrcargo.com for online transactions for courier exports operations.

The key features, benefits available and transaction charges for the ACS users have been shared by Kale Logistics are as detailed in Annexure A.

These features are only an indicative part of the feature list and accompanying benefits of the ACS Platform. Business partners are advised to familiarize themselves with these features to improve business efficiencies at our Air Cargo Terminal

Kale Logistics will also reach out to all Business Partners via email for onsite training on usage of the Portal and its various features in batches to be scheduled from 14 April 22.

Annexure A

key features of Kale ACS for GMR Hyderabad Air Cargo Courier Operators

- 1. Uploading of CSB1
- 2. Uploading of CSB2
- 3. Uploading exports manifest data
- 4. File Advance shipment information (ASI) to CTO
- 5. Shipment status updates

With reference to Airport Community Service charges, following charges shall be applicable for usage of the GMR cargo portal and will be applicable to Courier Operators and Freight Forwarders (Issuing Agents).

- 1. INR 160/- will be applicable on courier Master Air waybill (MAWB) per transaction.
- 2. All Courier Operators are advised to deposit and maintain a minimum of INR 1,500 (INDIAN RUPEES ONE THOUSAND FIVE HUNDRED ONLY) in the ACS Pre-Deposit Account (PDA) with Kale Logistics as per below mentioned bank account details.
- 3. Below Payment Modes are available for making a payment to the ACS PD account. Direct transfer / NEFT / RTGS the bank account details are as below:

- 4. Each entity, on depositing the amount (using any modes as mentioned in above point), must update the details of deposit in its respective PDA in ACS Portal, along with valid documentary proof (Deposit Receipt) and shall be communicated to M/s Kale Logistics Solutions Private Limited.
- 5. It is pertinent to note that the ACS Pre-Deposit account will be credited on receipts of funds in the Bank Account as mentioned in point 3. The transactions on ACS portal shall be allowed only in case of sufficient balance in the respective customer's pre-deposit account.
- 6. IGST (currently 18%) and any other statutory taxes, if any, shall be levied as per government notifications.
